

## Cash Passport Flight Centre Promotion – Terms & Conditions of Entry (“Conditions of Entry”)

### Entry

1. These Terms and Condition apply to the Cash Passport Flight Centre Promotion. Information on how to enter and prizes form part of these Conditions of Entry.
2. The promoter is Travelex Financial Services NZ Limited, Level 14, Brookfield House, 19 Victoria Street West, Auckland, Phone: 09 359 5113 (the “Promoter”).
3. There will be one prize draw as part of this promotion (“Draw”).
4. There will be one prize winner for the Draw
5. Entry to the Draw will be open from 30/01/10 until 31/03/10 inclusive (“Promotion Period”).
6. Entry to the Draw is open to any person who purchases or reloads a Travelex Cash Passport Card at a Flight Centre store in New Zealand during the Promotion Period (“Eligible Entrant”). Each Eligible Entrant will be automatically entered into the relevant Draw.
7. Each Eligible Entrant will receive one entry for each purchase or reload made to the Eligible Entrant’s Travelex Cash Passport Card during the Promotion Period.
8. Employees of the Promoter, Flight Centre and their related bodies corporate, and their immediate families are not eligible to enter this promotion.
9. All entries submitted become the property of the Promoter. All details will be held in accordance with Travelex Privacy Policy which can be accessed in New Zealand by visiting [www.travelex.co.nz](http://www.travelex.co.nz) or calling 0800 480 481.
10. Each Eligible Entrant agrees that the Promoter will collect and record their details and may use those details for the purpose of marketing the Promoter’s products and services to that entrant, unless otherwise advised by that entrant.
11. Except where prohibited by law, the winner agrees that the Promoter may use the name, address and photograph of the winner for promotions, marketing and publicity, unless otherwise advised.

### Draw

12. The Draw will take place at Travelex’s offices at Level 14, Brookfield House, 19 Victoria St West, Auckland, New Zealand.
13. The Draw will take place on 12 April 2010
14. For each Draw, the relevant Eligible Entries will be drawn randomly by being entered into a random number generator. The first Eligible Entry which corresponds to first random number generated by the random number generator will be the Prize winner.
15. The Prize winner of the Draw will be notified within 7 business days of the relevant Draw by phone and/or mail using the details provided by the Eligible Entrant.
16. In order to claim the Prize, the winner must consent to having their name published. If you do not consent to your name being published the Prize will be considered to be forfeited and a redraw will take place.

### Prize

17. The total prize for the Draw, will be NZ\$1000 or the relevant foreign currency equivalent in the currency of that card (the “Prize”).
18. The total prize pool for this promotion is valued at up to a maximum NZ\$1,000.
19. The winner’s Travelex Cash Passport Card will be credited with the Prize within 14 days of each Draw date.
20. The Prize must be taken as stated. The prize is not exchangeable or transferable and cannot be redeemed for cash or other goods or services. If a winner is unable to use the Prize as stated it will be forfeited and no compensation will be payable.

23. The Travelex Cash Passport Card is subject to the Travelex Cash Passport Terms and Conditions.

25. If the Prize remains unclaimed for 3 months after the relevant Draw a redraw will take place. The redraw (if required) will occur on 19 July 2010. The redraw will be conducted at the relevant premises set out above and the winner will be notified by phone and mail within 7 business days of the redraw.

### Other conditions

26. To the extent permitted by law, the Promoter and its associated agencies or companies are not liable for any:
  - a. Error, omission, interruption, deletion, defect, delay in operation, theft or destruction or unauthorised access to, or alteration of entries; or

- b. Loss or damage whatsoever (including but not limited to direct or consequential loss) or personal injury however caused including, but not limited to, by their or any of their negligence, suffered by the Entrant or any other person relating to the use or enjoyment of, or non-delivery or non-useability of, a prize.

If for any reason, the Promoter is unable to run this competition as planned, including tampering, infection by computer virus, bugs, unauthorised intervention, fraud, technical failures or any other causes beyond the control of the Promoter that corrupt or otherwise affect the administration, security, fairness, integrity or proper conduct of this competition, the Promoter may in its sole discretion disqualify any person who tampers with the entry process, and cancel, terminate, modify or suspend the promotion, subject however to any written directions given under applicable law.

28. The decision of the Promoter is final.
